Purposes and legal bases

- A. Handling of enquiries:** personal data are processed for all needs related to the processing of enquiries and/or quotations.

- C. Communication to third parties for Marketing purposes:** data is transmitted to third parties who, as autonomous data controllers, will process it for their own marketing purposes; in particular, Quadrifoglio transmits data to its business partners who attend the showroom: a list of partners and their contact details can be found on the website <https://www.qgdesignhub.it/>
- D. Defence purposes:** the Data Controller may need to process personal data for the management of extrajudicial or judicial disputes and litigation.

Rights of the Data Subject

The person to whom the personal data refer has the following rights:

Access: it is possible to know whether or not your personal data is being processed and, if so, to obtain access to it and request a copy.

Rectification: you can ask for your personal data to be updated, corrected (if inaccurate) and for incomplete data to be supplemented.

Cancellation: it is possible to obtain the cancellation of one's personal data if certain conditions are met (for more information contact the Data Controller).

Limitation: you may request that your data be marked, so as to limit its processing in the future, if certain conditions are met (please contact the Data Controller for more information).

Objection: you may object to the processing of your personal data, on grounds relating to your particular situation, where the processing is based on a legitimate interest or is necessary for the performance of a task carried out in the public interest or in the exercise of official authority vested in the Controller; you may also object to the processing of personal data for direct marketing purposes.

Portability: it is possible to receive in a structured format the personal data provided to the Controller and to ask for them to be transmitted to another data controller where the processing is based on consent or contract and is carried out by automated means.

Withdrawal of consent: it is possible to withdraw consent for the purposes for which it was requested, without prejudice to the lawfulness of the processing carried out up to that point.
